

Contributions to Karrin for Arizona are not deductible as charitable contributions for federal income tax purposes. An individual may contribute up to \$5,300 per election cycle and a couple may contribute up to \$10,600 per election cycle. Regular PACs may contribute up to \$5,300, and PACs that are certified as Mega PACs may contribute up to \$10,600. A Mega PAC is a PAC that, due to the large number of contributors to it, is allowed by law to make larger contributions than a regular PAC. All PACs must be registered with the Arizona Secretary of State in order to contribute. Contributions from corporations, LLCs, labor unions, and foreign nationals (non-green card holders) are prohibited. Arizona law requires Karrin for Arizona's best efforts to obtain and report the full name, residence address, occupation, and primary employer of any individual who contributes more than \$50 in an election cycle. For PAC contributions in any amount, Karrin for Arizona must make best efforts to obtain and report the PAC's name and physical/street address.
