

# **DEVELOPMENT IN SAN TAN VALLEY**

For many reasons, our County has seen increased interest from developers over the last several years. One of the first steps in any proposal is to look at our comprehensive plan, which outlines what can be built and where. This is commonly referred to as zoning, where pieces of land are designated as commercial, residential, industrial, etc. If a landowner chooses to build in compliance with existing zoning, that is their legal right to do so. If zoning changes

are requested, a developer must go through a multi-step process which includes traffic and water studies, gathering community feedback, and more. Upon completion, the case comes before the Board of Supervisors for a vote.

#### **CURRENT STATE**

Recently, several landowners pursued rezoning their property in our district. Thank you to all community members who provided feedback, these comments are taken very seriously and are included in official case records. As a resident of San Tan Valley myself, I share many of your concerns. While some projects fall in line with community needs, others do not. We need more commercial development, recreational spaces, employment opportunities, and a strong infrastructure to support our large population. However, I am one of five Pinal County Supervisors, and the only one that lives here. When it comes to the final vote, the majority prevails. This is another challenge of being unincorporated without a local City Council.

### WHAT WE ARE DOING

While there are limitations to what can be done at a county level, we are still taking creative steps to ensure a bright future for our residents, and we feel confident in our existing options for commercial development. Here are just a few of our recent projects that we hope will address some of your concerns:

- **Retail Study** Hired an outside consultant specializing in retail development to provide comprehensive analysis of retail opportunities in our area. We are leveraging this study to attract commercial and other developments.
- **Parks and Recreation** Working on public-private partnerships to build more parks in STV. We have identified pieces of land and hired consultants to provide park concepts for use when additional funding is secured.
- **Community Center** San Tan Valley is in need of a community core where residents can gather and have access to a wide variety of amenities. We are working with local landowners and community partners on this concept.

### HOW YOU CAN GET INVOLVED

Impacted property owners are invited to neighborhood meetings for the purpose of gathering feedback. Please attend and provide input. If the project is officially submitted, you can offer comments via email or in person at board meetings. For District 2, you can email myself, Mike.Goodman@pinal.gov. If the project is in District 4, you can email bosdistrict4@pinal.gov. For any project, you can also call the contact center at 520-509-3555. Lastly, don't forget to take our survey! Property owners and developers can use this data to make more informed decisions.
